

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with the San Diego Unified Port District involving property at the southerly end of Navy Field, for the purpose of providing a site for the construction and operation of recreational facilities for members of the armed forces for a term of fifty (50) years for a total prepaid lease rental of \$162,763.00, under the terms and conditions set forth in that Lease Agreement on file in the office of the City Clerk as Document No. RR-252477.

BE IT FURTHER RESOLVED, that said lease payment of \$162,763.00 is hereby authorized to be paid from funds received from the Redevelopment Agency of The City of San Diego in connection with the Redevelopment Agency's acquisition of the present site of the USO facilities at 510 West "F" Street, which funds have been deposited in the City's Capital Outlay Fund.
