BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled "TRADE BUSINESS PARK Being a subdivision of Lots 16, 17 and 20 of Kendall Miramar Business Park, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 9015, filed in the office of the County Recorder of San Diego County, November 3, 1978.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easement with the right of ingress and egress for the construction and maintenance of water facilities as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the general utility easement over, under, upon and across Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.


