BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of J. GREGORY LAWLOR ENTERPRISES, INC., a California corporation, executed in favor of The City of San Diego, bearing date of June 4, 1980, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along and across a portion of Lots 3 and 16 of La Cañada Canyon, Map No. 8923, as more particularly described in said deed, be, and the same is hereby approved and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named LA CAÑADA.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
