

RESOLUTION NO. R-252514 (R.81-196)

WHEREAS, SAN DIEGO GAS & ELECTRIC COMPANY, a corporation,
has requested an exchange of overhead electrical easements;
and

WHEREAS, the City Manager has certified that the values of
the property rights to be exchanged are equal; and

WHEREAS, the easements to be acquired will serve the same
use and purpose as the easements to be conveyed by the City;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the acceptance by the City Manager of that
quitclaim deed of SAN DIEGO GAS & ELECTRIC COMPANY, a
corporation, executed in favor of The City of San Diego, bearing
date of June 18, 1980, relinquishing to said City the overhead
electrical easement in a portion of Lot 13, Rancho Mission San
Diego, as more particularly described in that deed, is hereby
approved.

2. That the Mayor and City Clerk of said City be, and
they are hereby authorized and empowered to execute, for and
on behalf of The City of San Diego, an easement deed, a copy
of which is on file in the office of the City Clerk as
Document No. RR-252514, conveying to SAN DIEGO GAS
& ELECTRIC COMPANY, a corporation, an overhead electrical
easement in Lot 13, Rancho Mission San Diego, as more
particularly described in that deed.

3. That the City Clerk of said City is hereby authorized and directed to deliver said deeds, and a certified copy of this resolution, to the Property Department for further handling.
