That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City a First Amendment to Agreement with PRC TOUPS, CONSULTANT to increase the scope of work of the existing agreement to include design of an interim project to stabilize designated critical areas of erosion in Crest Canyon, said agreement is on file in the office of the City Clerk as Document No. RR-252522.

BE IT FURTHER RESOLVED, that the expenditure of \$15,000 from the C.I.P. No. 23-547, Crest Canyon Erosion Control, Special Environmental Growth Fund No. 10505, of The City of San Diego, be hereby authorized, solely and exclusively, for the above-stated purpose.
