
BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer the sum of \$12,075.00 from Miscellaneous Street Improvements CIP 58-004 to Rowena Street Slide Reconstruction CIP 52-273, solely and exclusively for the above project.
