BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the City of San Diego is hereby authorized to participate with the Port of San Diego in the La Playa Beach restoration.

BE IT FURTHER RESOLVED, that the expenditure of \$10,000 is hereby authorized from Sewer Revenue Fund 41506, solely and exclusively for the City's participation in the restoration of La Playa Beach.
