

RESOLUTION No. RA-252530 (R-81-79 )



BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a five-year Right-of-Entry Permit with AMERICAN TELEVISION AND COMMUNICATIONS CORPORATION, a Delaware Corporation, dba Southwestern Cable TV, for continued operation and maintenance of an underground cable and microwave antenna site on a portion of Miramar Reservoir property, commencing at a monthly rental of \$220, under the terms and conditions set forth in the permit on file in the office of the City Clerk on file in the office of the City Clerk as Document No. RA 252530.

BE IT FURTHER RESOLVED, that the requirements of Council Policy No. 700-10 are hereby waived.
