WHEREAS, it is in the City's best interest for the City Attorney to attend and participate in the planned conferences;  
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Attorney be and he is hereby authorized to travel to Monterey, California, during the period September 26 through October 1, 1980, for the purpose of attending conferences of the California District Attorneys' Association as a board

member and the Executive Committee of the California State Bar Association Public Law Section.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$500 from the Unallocated Reserve (605) to the Allocated Reserve (901) to be used solely and exclusively for the above travel.
