EXHIBIT A

Street Dedication

A portion of Lot A-245 of Addition No. 5, to San Ysidro, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 1405, filed in the office of County Recorder of San Diego County, January 2, 1912, described as follows:

Beginning at the Southeasterly corner of said Lot A-245, being also a point on the northerly line of Blackshaw lane 20.00 feet wide as per said Map 1405; thence North  $00^{\circ}05'07''$  East along the East line of said lot, a distance of 20.00 feet; thence North  $89^{\circ}54'53''$  West 63.00 feet; thence South  $00^{\circ}05'07''$  West 6.00 feet; thence North  $89^{\circ}54'53''$  West 68.96 feet to the beginning of a tangent 11.00 foot radius curve, concave Northeasterly; thence Northwesterly along the arc of said curve through a central angle of  $54^{\circ}39'49''$  a distance of 10.49 feet to a point of cusp in the arc of a 20.00 foot radius curve, concave Northeasterly; thence Southerly, Southeasterly and Easterly along the arc of said curve through a central angle of  $86^{\circ}00'54''$  a distance of 30.02 feet to a point on the Southerly line of said Lot A-245; thence South  $89^{\circ}54'53''$  East along said Southerly line, a distance of 120.96 feet returning to the Point of Beginning.
