<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Frank O. Lovett	Park and Recreation	\$1,405	Mr. Lovett is a Carpenter in the Coastal Division. He suggested a new method of fabricating navigational buoys. Estimated first year's savings are \$9,249 in labor and material costs. This is a partial award pending a final 12-month review.
Jeanne E. Totino	City Treasurer	\$1,000	Ms. Totino is an Intermediate Clerk. She suggested that an automatic delinquent fee be charged when citations are paid with a bad check. This has produced an additional \$15,000 in revenue in one year of use.
Jonathan T. Harker	Building Inspection	\$ 345	Mr. Harker is an Intermediate Typist. He developed a new method of releasing gas and electric meters to San Diego Gas and Electric. Estimated first year's savings are \$2,298 in processing costs. This is a partial award pending a final 12-month review.
Maureen Farmer Veronica Cole	General Services	\$ 155	Ms. Farmer is a Senior Clerk, and Ms. Cole is an Auto Messenger in the Buildings Division. They suggested that parking citations be presorted by computer to reduce postage costs. Estimated first year's savings are \$522.
Beverly M. Bacon	Personnel	\$ 150	Ms. Bacon is an Intermediate Typist. She suggested that all qualified applicants be certified pending medical examination. Estimated first year's savings are \$500 in processing costs.
