WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Maureen Farmer	General Services	\$ 140	Ms. Farmer is a Senior Clerk in the Buildings Division. She suggested that Mailroom staff distribute the PDL. Estimated first year's savings in processing costs are \$462.
Vincent DeLeva	General Services	\$ 110	Mr. DeLeva is an Electrical Supervisor in the Communications and Electrical Division. He suggested that the lighting time in the Zoo parking lot be reduced. This is expected to save \$2,260 in energy costs in the first year of use. This is a partial award pending a final 12-month review.
Michael D. Eacobellis Earnest D. Warren.	General Services	\$ 105	Mr. Eacobellis and Mr. Warren are Equipment Mechanics in the Equipment Division. They suggested that dimmer switches be relocated on master packers. This is expected to save \$1,053 in repair costs in the first year of use.
William L. Colding Rosalie A. Gonzalez	General Services	\$ 100	Mr. Colding and Ms. Gonzalez are Sanitation Inspectors in the Streets Division. They suggested that a system of mini neighborhood clean-ups be initiated to replace 80% of all clean-ups. This is expected to save \$11,200 in the first year in labor costs. This is a partial award pending a final 12-month review.
Thomas C. Feldscher	Fire	\$ 100	Mr. Feldscher is a Fire Fighter. He suggested a revised method for testing hose that greatly reduces the potential for injury. This was considered to be a significant safety improvement.
