WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Raymond F. Fobert	Police	\$ 100	Mr. Fobert is a Sergeant. He suggested that Form PD-587 no longer be used when a juvenile truant is contacted and returned to school. This saves an estimated \$1,976 annually in processing costs. This is a partial award pending a final 12-month review.
Wanda N. Polk	General Services	\$ 95	Ms. Polk is an Auto Messenger in the Buildings Division. She suggested a revision to mail run routes that is expected to save \$640 annually in labor costs. This is a partial award pending a final 12-month review.
Carol Harrison Friscilla Lindberg	General Services	\$ 90	Ms. Harrison is an Intermediate Typist, and Ms. Lindberg is a Dispatch Clerk in the Equipment Division. They suggested that the recording of the condition of vehicles sold in San Diego be eliminated. This saves \$300 annually in labor costs.
Charles B. Einolander	General Services	\$ 85	Mr. Einolander is an Equipment Mechanic in the Equipment Division. He suggested that mobile sweeper auxiliary sprinkler system water pumps be relocated to a more accessible location. This is expected to save \$289 annually in maintenance costs.
Robert L. Davis	General Services	\$ 75	Mr. Davis is a Plumber in the Buildings Division. He suggested that a time clock be installed on the heating system at the House of Hospitality. This is expected to save \$520 annually in repair cost. This is a partial award pending a final 12-month review.
