That the following suggestion awards are hereby approved and the Auditor and Comptroller i hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Herb M. Yaklin	Park and Recreation	\$ 25	Mr. Yaklin is a Utility Worker I in the Central Division. He suggested a relocation of the hand brake control on equipment #5332. This was considered to be a significant safety improvement.
Harold F. Keezer	Fire	\$ 25	Mr. Keezer is an Engineer. He suggested the relocation of equipment on Clark fire engines. Savings are impossible to calculate, but this was considered to be a significant operational improvement.
John E. Gardner	Engineering and Development	\$ 25	Mr. Gardner is an Assistant Civil Engineer. He suggested that one less copy of plans be made for special permits and sub-division improvements. This was considered to be a significant public service improvement.
Robert L. Davis	General Services	\$ 25	Mr. Davis is a Plumber in the Buildings Division. He suggested that storeroom personnel be required to check oil deliveries at the 20th and B operations station. This was considered to be a significant operational improvement.
Wallace J. Ullman	Water Utilities	\$ 20	Mr. Ullman is a Senior Utility Supervisor in the Systems Division. He suggested the use of hollow break-off bolts at the base of each fire hydrant. Savings are indeterminable at this time. This was considered to be a significant operational improvement.
