Anne Rafferty	Water Utilities	\$ 20	Ms. Rafferty is an Intermediate Clerk in the Services Division. She suggested that the night deposit box for the City Operations Building be relocated. This was considered to be a significant public service improvement.
Mary H. Middendorf	Water Utilities	\$ 20	Ms. Middendorf is an Assistant Chemist. She suggested that battery eliminators be made for laboratory instruments by the electronics section. Although savings could not be calculated, this was considered to be a significant operational improvement.
John M. Whyte	Fire	\$ 20	Mr. Whyte is a Captain. He suggested that the 06:45 test of the paging and tele-printer systems be eliminated. Although savings could not be calculated, this was considered to be a significant operational improvement.
Willie C. Shipley, Jr.	General Services	\$ 20	Mr. Shipley is a Sanitation Driver II in the Solid Waste Division. He suggested that a metal cover be fabricated to cover the valve body for 9605 series packers. This was considered to be a significant safety improvement.
Davis P. Bell	General Services	\$ 20	Mr. Bell is an Electrician in the Communications and Electrical Division. He suggested that a hand operated damper be installed on the register of the electronic room conference room. Savings could not be calculated, but this was considered to be a significant conservation improvement.
