<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Calvin Chong	Engineering and Development	\$ 20	Mr. Chong is an Associate Civil Engineer. He suggested that elevator bells be timed to ring five seconds prior to the elevator arriving at a floor. Although savings could not be calculated, this was considered to be a significant operational improvement.
Maureen Farmer	General Services	\$ 20	Ms. Farmer is a Senior Clerk in the Buildings Division. She suggested that only small orders of letterhead and envelopes be ordered in anticipation of the implementation of nine digit zip codes. Although savings could not be calculated, this was considered to be a significant operational improvement.
John A. Trent	Police	\$ 20	Mr. Trent is a Police Officer. He suggested that updates to the investigative notebook be printed on paper that will fit in the notebook. Although savings could not be calculated, this was considered to be a significant operational improvement.
Craig W. Black	Fire	\$ 20	Mr. Black is an Engineer. He developed a weekly Hurst rescue tool maintenance sheet. Savings could not be calculated, but this was considered to be a significant preventive improvement.
Helen L. Rust Sally A. Dixon	Police	\$ 20	Ms. Rust and Ms. Dixon are Data Entry Operators. They suggested that a warning sign be placed on inside doors of Police Department restrooms. Savings could not be calculated, but this was considered to be a significant safety improvement.
