

RESOLUTION NO. R-352554 (R. 81-333)

WHEREAS, with the approval of the final map of CLAIREMONT-KEMPER CONDOS subdivision, the City shall receive easement interests which allow the quitclaim of an existing drain easement within the subdivision; and

WHEREAS, the City Manager has certified that the easement interests to be exchanged are approximately equal in value;

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-352554-1 quitclaiming to BAYCLAIRE DEVELOPMENT CORPORATION, a California corporation, all the City's right, title and interest in the drain easement, as more particularly described in said quitclaim deed.
