WHEREAS, in proceedings under the Municipal Improvement Act of 1913 (commencing with Section 10000, Streets and Highways Code) the Council heretofore adopted Resolution of Intention No. 212224 and subsequently ordered certain improvements and the formation of the Standley Park Assessment District pursuant thereto; and

made or filed in the matter of the proposed change are hereby
overruled and denied.
