APPROVING MAP OF SKYLINE PENASQUITOS UNIT NO. 3
AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S
ASSURANCE OF COMPLIANCE WITH THE AFFIRMATIVE
MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by GLENN R. FERGUSON, a Licensed Land Surveyor, entitled
"SKYLINE PENASQUITOS-UNIT NO. 3 Being a subdivision of
a portion of Rancho Los Penasquitos, according to Map
accompanying the patent to said Rancho recorded in the
office of the County Recorder of San Diego County, in
Book 2, Page 385 of Patents, together with a portion of
Carmel Mountain Road as dedicated to public use, all being
in the City of San Diego, County of San Diego, State of
California.," is made in the manner and form prescribed by
law and conforms to the surrounding surveys; that said
Council hereby accepts on behalf of the public, the
following: High Park Lane and Grain Lane for public purposes;
and said streets are hereby declared to be public streets
and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council hereby
accepts on behalf of The City of San Diego, a municipal
corporation, any and all abutter's rights of access in
and to Carmel Mountain Road, adjacent and contiguous
to Lots 1 through 15, all as shown on this map within this
subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutter's rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
