
WHEREAS, the City has received new drain easements for an existing drain easement; and

MORAN, a single man and PLUM MORAN, a widow, as joint tenants; JOSEPH RIZZO and MARY RIZZO, Trustees under Declaration of Trust dated November 23, 1976; SAMUEL R. LUNDGREN and ETHEL J. LUNDGREN, husband and wife as joint tenants; ROBERT D. WILCOX, JR. and LILLIAN WILCOX, husband and wife as joint tenants; and RALPH GOLDVARG and YETTA GOLDVARG, husband and wife as joint tenants; as record owners, all the City's right, title and interest in the drain easement, as more particularly described in said quitclaim deed.
