
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a three (3) year Lease Agreement with SAN DIEGO CONSISTORY NO. 91, which Lease Agreement is subject to termination upon 30-days' notice by either party, for approximately 13 acres of former Mount Hope Cemetery land, for the purpose of recreational gardening at an annual rent of One Dollar (\$1), under the terms and conditions set forth in that Lease Agreement on file in the office of the City Clerk as Document No. RR-252657.

BE IT FURTHER RESOLVED, that the City Manager is authorized to designate the existing "construction" water meter as a "permanent" water meter and pay the additional \$175 meter service charge out of Revenue Sharing Social Services Fund No. 19623.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to waive the lease processing fee of \$110.
