That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a five-year Lease Agreement with CENTRO CULTURAL DE LA RAZA, a non-profit corporation, for a portion of Balboa Park, for the purposes of operating and maintaining office quarters, and providing for cultural activities, art and graphic workshops, shows and displays and public and civic activities, at an annual rental of \$2,400.00, under the terms and conditions set forth in that Lease Agreement on file in the office of the City Clerk as Document No. RR-252658.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to waive any unpaid rent on the property which was due on or before June 30, 1980.
