BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to pay the total sum of \$7,500 in the settlement and release between Torrey-Sorrento Associates No. 2, the City of San Diego, and the Archaeological Resource Management Society, and of each and every claim against the City of San Diego, its agents and employees, resulting from the adverse impacts on archaeological resources on property owned by Torrey-Sorrento Associates No. 2 at the end of Rozelle Street in the Sorrento Valley area.


