WHEREAS, by Resolution No. 252639, adopted on September 8, 1980, the Council directed City staff to repurchase Parcel 1 of Lot 10, Torrey Pines Science Park, from IRT Corporation due to nonperformance of construction commitments; and

WHEREAS, funds for such repurchase are required; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the transfer of \$560,000.00 from the CIP Project No. 39-040 to provide funds for the repurchase of Parcel 1, Lot 10, Torrey Pines Science Park, is hereby authorized and the expenditure of such funds for the repurchase is hereby approved.

BE IT FURTHER RESOLVED, that the addition of CIP 39-016.4 (Torrey Pines Science Park, Unit No. 2, portion of Lot 10 Repurchase) to the FY 1981 Capital Improvements Program is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept the deed from IRT Corporation reconveying Parcel 1, Lot 10, Torrey Pines Science Park to the City of San Diego.
