
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a supplemental agreement with the STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION, for participation in the widening of Carmel Mountain Road from I-15 to Penasquitos Drive, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RC-252701-1.

BE IT FURTHER RESOLVED, that the expenditure of \$55,000, previously deposited by the developers of the project, is hereby authorized from Trust Fund 63021 solely and exclusively for this purpose.

BE IT FURTHER RESOLVED, that it be and it is hereby certified that the information contained in the Negative Declaration prepared by the State of California's Department of Transportation, a copy of which is on file in the office of the City Clerk of The City of San Diego as Document No. RC-252701-2, dated September 14, 1971, has been reviewed and considered by this Council.
