That Change Order No. 3, dated July 11, 1980, heretofore filed with the City Clerk of said City as Document No. A-252704, issued in connection with the contract between The City of San Diego and Long, Marker & Howley Construction Company for the CONSTRUCTION OF WATER MAIN REPLACEMENT GROUP 408, said contract having been filed in the office of the City Clerk as Document No. 766853, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$10,320.00, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that an additional expenditure of \$70,000 is hereby authorized for City Force work to make operational checks and connections where required.

BE IT FURTHER RESOLVED, that the additional expenditure of \$80,320.00 is hereby authorized from the Annual Allocation for Water Main Replacements, solely and exclusively for this purpose and related costs.
