

RESOLUTION NO. RC-252709

(R.81-501)

WHEREAS, the Transportation and Land Use Committee, at **SEP 22 1980**  
its meeting of August 6, 1980, recommended uses of certain  
City-owned vacant land to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

That the Transportation and Land Use Committee recommenda-  
tions on those City-owned sites numbered 628, 732 Area A, 732  
Area B, 733-738, 739 Area A, 739 Area B, 740-744, 746 and  
748, as shown on that Document No. RC-252709 on file  
in the office of the City Clerk, are hereby approved.

BE IT FURTHER RESOLVED, that the City Council, by making  
the above designation, in no way intends to bind itself to  
utilize the property in accordance with the designation, and  
the Council specifically intends to be able to change the  
designation at any time or utilize the property for any  
purpose determined to be in the best interest of the City at  
the sole discretion of the Council.

BE IT FURTHER RESOLVED, that this designation serves  
simply and exclusively as a tentative guide to the City staff  
with regard to potential use of vacant City-owned land and  
that it is the Council's intent that this designation and  
past designations of this nature have no legal or binding  
effect whatsoever beyond serving as a tentative guide to such  
staff.
