WHEREAS, the Council of the City of San Diego (Council) has authorized the City Manager to amend the 1979 Community Development Block Grant application to include a request to the U.S. Department of Housing and Urban Development (HUD) for a Loan Guarantee of \$7,917,662, inclusive of interest, under Section 108 of the Housing and Community Development Act of 1974, for the purpose of property acquisition and site assembly in the Marina/Columbia Redevelopment Projects; and

WHEREAS, HUD has approved the amended application; and

WHEREAS, the Council has authorized the City Manager to execute, on behalf of the City, a Grant Agreement for the Loan Guarantees;

NOW, THEREFORE, BE IT RESOLVED as follows:

- That the City Manager be, and he is hereby authorized to execute an agreement with the Redevelopment Agency of the City of San Diego (Agency) for use by the Agency of the proceeds of the Loan Guarantees in accordance with the Project Budget and Work Program which is on file with the City Clerk as Document No. 1252714
- That the City Auditor be, and he is hereby authorized and directed to transfer the proceeds of said Loan Guarantees to the Agency for use in property acquisition and site assembly in the Marina/Columbia Redevelopment Projects in accordance with said agreement.
- That the disbursement of said funds from the City to the Agency are loans which are to be repaid by the Agency from tax increments or other revenues. In the event that the Agency desires to issue bonds, notes, or other instruments of indebtedness to carry out the projects of the Agency, then any pledge of Agency revenues to the City created under this resolution shall be subordinated to any pledge of tax increments or other revenues to bondholders or the holders of other such instruments of indebtedness.
