

RESOLUTION NO. R-252717Adopted on SEP 23 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Michael H. Hix	Engineering and Development	\$320	Mr. Hix is an Assistant Traffic Engineer. He was awarded a \$150 award several months ago for his suggestion to simplify the travel forecasting process. This partial award was mistakenly based on the 10% award schedule. This is the remainder of his partial award based on the 30% award schedule.
Stephen E. Tallian	Planning	\$250	Mr. Tallian is a Graphics Supervisor. He suggested that the ownership maps being prepared for use at hearings and meetings be discontinued. The estimated annual savings are \$1,683 in preparation costs. This is a partial award pending a final 12-month review.
Richard L. Hoot	Police	\$245	Mr. Hoot is a Sergeant. He suggested that off-road, non-injury Police vehicle accidents involving other City owned property or equipment be reported using a less involved reporting system. This is expected to save \$1,656 annually in processing costs. This is a partial award pending a final 12-month review.
Henrietta L. Barnett Ronald H. Ransom	Water Utilities	\$215	Ms. Barnett and Mr. Ransom suggested that a mail run be eliminated. This saves an estimated \$713 annually.
Lisa L. Bodecker	City Auditor	\$130	Ms. Bodecker is an Intermediate Typist. She suggested that the uniform fringe benefit report be revised. This saves \$1,287 per year in processing costs.
