WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Joan M. Dolan	Planning	\$120	Ms. Dolan is an Intermediate Stenographer. She suggested that certified mail not be used to send permits to applicants for signature and notarizing. This is expected to save \$401 annually in processing costs.
Norma J. MacGregor Rachel A. Purdy	Police	\$ 75	Ms. MacGregor and Ms. Purdy are Intermediate Typists. They suggested a method of reducing the typing on Child Abuse Cross-Reference Cards. This is expected to save \$514 annually in processing costs. This is a partial award pending a final 12-month review.
Virginia R. Edwards	City Attorney	\$ 70	Ms. Edwards is a Senior Clerk. She suggested that resolution numbers be assigned over the phone for routine resolutions. Savings are \$718 annually in processing costs.
Valerie S. Smith	Risk Management	\$ 65	Ms. Smith is a Senior Typist in the Public Liability section. She developed a cross-reference index file for liability claims by location. This is expected to save \$1,273 annually in investigation costs. This is a partial award pending a final 12-month review.
Drago Skripeli	Engineering and Development	\$ 50	Mr. Skripeli suggested that credit cards be issued to material testing lab employees with which to purchase gas. This saves an estimated \$163 annually in labor costs.
