WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller hereby directed to issue warrants out of the General Fund for the following suggestions:

| <u>NAME</u> | <u>DEPARTMENT</u> | <u>AMOUNT</u> | <u>SUGGESTION</u> |
|-----------------------------------|-------------------|---------------|---|
| Delorèse J. Shafer | Risk Management | \$40 | Ms. Shafer is an Intermediat Typist in the Group Insurance Section. She suggested that life insurance premiums for two different plans be paid on the same Request for Direct Payment. This saves \$130 per year in processing costs. |
| Dolores E. Ruiz | Police | \$35 | Ms. Ruiz is a Dispatch Clerk I. She suggested a format change for the status field of complaints when Paramedics respond. This is expected to save \$119 annually in verification costs. |
| Roy C. Wamback | General Services | \$30 | Mr. Wamback is a Custodian II in the Buildings Division. He suggested that the use of roll towels be discontinued. This is expected to save \$92 annually in material costs. |
| Leon Colding Rosie A. Gonzalez | General Services | \$30 | Mr. Colding and Ms. Gonzalez are Sanitation Inspectors in the Solid Waste Division. They suggested that the citizen complaint form be reduced from three copies to two copies. This saves \$100 annually in form costs. |
| Aaron T. Foust | Fire | \$25 | Mr. Foust is a Fire Fighter. He suggested that a large flood light be installed on the rear of off-road fire engines. This was considered to be a significant safety improvement. |
