That the City Manager is hereby authorized to execute an amendment to that Agreement between The City of San Diego and the San Diego Housing Commission, on file in the office of the City Clerk as Document No. RR251956, which Agreement provides for the administration of housing rehabilitation projects and which amendment expands the areas for rehabilitation to include Housing Improvement Areas Nos. 2, 3 and 4 (Barrio Logan, City Heights Area), under the terms and conditions set forth in that amendment on file in the office of the City Clerk as Document No. RC-252725.

BE IT FURTHER RESOLVED, that the expansion of the eligible rehabilitation areas does not increase the previously authorized expenditure of \$3,070,913.00 (5th Year CDBG) approved by Council Resolution R-251956.
