BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Personnel Director be, and he is hereby authorized and empowered to execute, for and on behalf of said City, agreements with the SAN DIEGO REGIONAL EMPLOYMENT AND TRAINING CONSORTIUM (RETC) to accept no more than \$2,850,000 in CETA Title II-D funds and \$1,230,000 in CETA Title VI funds for CETA Public Service Employment programs for the City and Subagents for the period October 1, 1980 through December 31, 1980, said agreements are on file in the office of the City Clerk as Documents Nos. RL-252730-1 and RL-252730-2, respectively.

BE IT FURTHER RESOLVED, that the Personnel Director be and he is hereby authorized and empowered to execute and modify as necessary, for and on behalf of said City, agreements with the following agencies to increase or decrease funds within the total Title II-D and Title VI allocations received from RETC for the operation of the Public Service Employment Programs pursuant to the Comprehensive Employment and Training Act (P.L. 95-524), Title II-D and Title VI, through December 31, 1980, said agreements are on file in the office of the City Clerk under document numbers listed below:
