That the bid of SAN DIEGO LANDSCAPE MAINTENANCE CO. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing the City of San Diego with COMPLETE TREE AND SHRUB MAINTENANCE WITHIN THE DOWNTOWN BEAUTIFICATION DISTRICT OF APPROXIMATELY 1,383 PLANTER UNITS AND WITH COMPLETE LANDSCAPE MAINTENANCE OF APPROXIMATELY FIFTY-SIX (56) PLANTER AREAS AND SEVEN (7) PLANTER TUBS IN CENTRE CITY WAY as may be required for a period of twelve (12) months beginning August 1, 1980 through July 31, 1981, per prices on file in the Purchasing Dept.; terms 2% 20 days, with options to renew the contract for two (2) additional twelve (12) month periods with prices not to exceed 15% of bid price for each of the two (2) option years.
