APPROVING MAP OF SYCAMORE ARMS II AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by JAMES H. ALGERT, a Registered Civil Engineer, entitled "SYCAMORE ARMS II Being a subdivision of Lot A-60 of San Ysidro, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1174, filed in the office of the County Recorder of San Diego County, April 10, 1909.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public a portion of Sycamore Road for public purposes, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public street is accepted on behalf of the public as heretofore stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider,
