That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the STATE OF CALIFORNIA, DEPARTMENT OF PARKS AND RECREATION for the purpose of receiving a Planning Grant in the amount of \$45,000 for the Spreckels Organ Pavilion Restoration--Phase II Project, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-252750-1

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, a Second Amendment to Agreement with SZABO & CARRICK, Architects, for professional services required for the Spreckles Organ Pavilion Restoration--Phase II Project, under the terms and conditions set forth in the Second Amendment to Agreement on file in the office of the City Clerk as Document No. RR-252750-2.

BE IT FURTHER RESOLVED, that the expenditure of \$90,000 is hereby authorized from Spreckels Organ Pavilion Restoration Fund 39010, solely and exclusively for this purpose and related project costs.
