That Change Order No. 5, dated May 28, 1980; Change Order No. 7, dated May 6, 1980; and Change Order No. 8, dated July 29, 1980, heretofore filed with the City Clerk of said City as Documents NO. RR-252754-1, No. RR-252754-2, and No. RR-252754-3, respectively, issued in connection with the contract between The City of San Diego and Metro-Young Construction Company for construction of improvements of TORREY PINES SCIENCE PARK - UNIT 3, said contract having been filed in the office of the City Clerk as Document No. 766567, be and the same are hereby approved; and the changes therein set forth amounting to a net increase in the contract price of \$15,279.41, \$29,651.40 and \$7,760.27, respectively, for a total net increase of \$52,691.08, be and they are hereby approved.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer the sum of \$68,500 from Campus Point Subdivision (Resolution No. 224096) to Torrey Pines Science Park - Unit 3 (C.I.P. 39-016.2), solely and exclusively for this project.
