APPROVING MAP OF VILLA COLINA UNIT NO. 1 AND
ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE
OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING
PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by JOHN M. LEACH, a Registered Civil Engineer, entitled
"VILLA COLINA UNIT NO. 1 Being a subdivision of a portion
of Parcel 3 of Parcel Map No. 8547 filed in the office of
the County Recorder in the City of San Diego, County of San
Diego, State of California, recorded March 19, 1979.," is
made in the manner and form prescribed by law and conforms
to the surrounding surveys; that said map and the subdivi-
sion of land shown thereon is hereby approved and accepted;
and said Council hereby accepts on behalf of the public
Calle Mariselda for public purposes, and said street is
hereby declared to be a public street and dedicated to the
public use.

BE IT FURTHER RESOLVED, that said Council hereby
accepts on behalf of The City of San Diego, a municipal
corporation, the easements with the right of ingress and
egress for the construction and maintenance of water and
drainage facilities, as granted and shown on said map and
subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for general utility purposes over, under, upon and across Lot 2, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that those easements with the right of ingress and egress for construction and maintenance of water and drainage facilities, and the easement for general utility purposes as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, TIERRASANTA NORTE, a California partnership, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City clerk, and in reliance on said assurance does hereby accept the final map of VILLA COLINA UNIT NO. 1.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
