
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Grant Deed of ROSA ELVIRA KAMBER and AMOR CHRISTINA KAMBER, mother and daughter as joint tenants, executed in favor of The City of San Diego, bearing date of August 8, 1980, conveying to said City all that portion of the South Half of the South Half of the Northeast Quarter of the Northwest Quarter of Section 35, Township 18 South, Range 2 West, San Bernardino Meridian, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 1, is hereby named DAIRY MART ROAD.

That the expenditure of not to exceed \$100,000 from Gas Tax Fund 30219 for acquisition and related expenses for this parcel and other parcels in the project is hereby approved.

That the City Clerk is hereby authorized and directed to deliver said deed, and a certified copy of this resolution attested by him under seal, to the Property Department for further handling.
