WHEREAS, in 1972, the City of San Diego entered into an agreement with a non-profit corporation for the purpose of issuing tax emempt bonds to finance the construction of a 189 bed Hospital at 26th Street and Island Street, known as COMMUNITY HOSPITAL; and

WHEREAS, a provision of the agreement required that in the event bond interest and redemption payments were not made, thus creating a default, the City would have first option to purchase the property; and

WHEREAS, on September 8, 1980, the City was advised by Crocker National Bank that Community Hospital of San Diego had defaulted in the payment of interest on bonds issued pursuant to the indenture and the City has thus been given an option to purchase all right, title and interest of the corporation in and to the Hospital facility; and

WHEREAS, the City Council determined that the public health, safety and general welfare require the continuing operation, if economically feasible, of Community Hospital in order to provide needed medical service to the community; NOW, THEREFORE,

BE IT RESOLVED, that the City Manager or his authorized representative is hereby authorized and empowered to give notice to Crocker National Bank of the City's intent to exercise its option to purchase the Community Hospital of San Diego, a copy of which notice is on file in the office of the City Clerk as Document No. R-252815.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$27,500 from the General Fund Unallocated Reserve is hereby authorized for the following purposes:

- To hire a consultant to prepare a request
 for proposal designed to select a qualified operator for
 Community Hospital of San Diego (not to exceed \$10,000);
- 2. To engage an independent fee appraiser qualified to evaluate the Hospital facilities, to determine the value of the Hospital facilities and the adjacement parking lot (not to exceed \$7,500); and
- 3. To retain outside legal counsel satisfactory to the City Attorney to assist in review and preparation of documents and with regard to any litigation involved in proceeding with the City's option to acquire the Hospital (not to exceed \$10,000).
