BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street and Drainage Easement Deed of GENSTAR DEVELOPMENT, INC., a New York corporation, executed in favor of The City of San Diego, conveying to said City a drainage easement and an easement for public street purposes over, along and across a strip of land in RANCHO DE LOS PENASQUITOS, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named SALMON RIVER ROAD.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
