WHEREAS, the Housing Authority of the City of San Diego has notified the owners of the Del Sol Apartments that it intends to exercise its option to purchase the units, and

WHEREAS, the Authority has resolved to assign said option to the City of San Diego;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. The City of San Diego accepts from the Housing Authority of the City of San Diego an assignment of its option to purchase Del Sol Apartments for \$1.8 million.
- 2. The City Manager is authorized and directed to perform any and all actions necessary to complete acquisition of Del Sol Apartments including, but not limited to taking title to the Del Sol Apartments, subject to existing loans totaling approximately \$203,500 with Home Savings and Loan Association, and depositing in escrow a sum not to exceed \$1,001,500 from the Low-Income Capital Outlay Fund for acquisition and closing costs.
- 3. The addition of CIP Project 37-167 (Del Sol Apartments) to the FY1981 Capital Improvements Program is hereby authorized.
- 4. The transfer of \$600,000 from CIP Project 37-055.4 (West Miramar Sanitary Fill) to CIP Project 37-167 (Del Sol Apartments) is hereby authorized.
- 5. The expenditure of \$1,001,500 for the above purpose from the Low-Income Capital Outlay Fund No. 30249 and encumbrance of \$803,500 (\$203,500 from the Low-Income Capital Outlay Fund No. 30249 and \$600,000 from Capital Outlay Fund No. 30245, CIP Project 37-167 Del Sol Apartments) to secure the loan are hereby approved.

6. The City Manager is hereby authorized to execute a First Amendment to the Property Management Agreement with the Housing Authority of the City of San Diego, a copy of which is on file in the Office of the City Clerk as Document No. RR- 252826.
