RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING CERTAIN CHANGES AND MODIFICATIONS IN THE PROJECT UNDER RESOLUTION OF INTENTION NO. 250499 IN THE MATTER OF THE IMPROVEMENT OF MIRAMAR ROAD BETWEEN I-805 AND AT&SF RAILWAY CROSSING AND EASTGATE MALL BETWEEN I-805 AND MIRAMAR ROAD BY THE INSTALLATION OF SEWER AND WATER MAINS.

WHEREAS, this City Council did on October 29, 1979, adopt its Resolution of Intention No. 250499, declaring its intention to order the construction of certain improvements in the City of San Diego; and

WHEREAS, this City Council did on SEP 24 1980, 1980, adopt Resolution No. R- 252711 proposing to make certain changes and modifications in the project as described in said resolution of intention; and

WHEREAS, the hearing has been held on said proposed changes, all in the manner and form prescribed by law, and objections not having been made by the owners of one-half of the area of the property proposed to be assessed, and this Council now having jurisdiction to make said changes and modifications; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the public interest and convenience require certain changes and modifications in the project for the assessment district originally set forth in Resolution of Intention No. 250499, which changes and modifications are duly described

and set forth in Resolution No. R- 252711, adopted by this Council on SEP 22 1980 19 . This Council hereby orders said changes and modifications as set forth in said last noted resolution.
