WHEREAS, the Fire Department has been offered a \$15,000 grant to help implement a new incident reporting system (NFIRS) which would meet current and future needs and result in improved data collection and retrieval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That The City of San Diego and the San Diego Fire Department hereby accept a \$15,000 grant from the U.S. Fire Administration for development and operation of a city wide fire incident reporting system, said grant agreement is on file in the office of the City Clerk as Document No. RR-252835.

BE IT FURTHER RESOLVED, that the San Diego Fire Department is hereby authorized to spend \$60,521 for this purpose.


