

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

3E IT FURTHER RESCLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

CONSTRUCTION OF SOUTH CHOLLAS PARK - INITIAL DEVELOPMENT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$35,568.00 from PSD 11620, \$26,049.00 from PSD 15580, \$39,581.00 from PSD 15582, \$22,308.00 from PSD 15590, \$67,916.00 from PSD 15592, \$52,743.00 from PSD 15600, \$31,645.00 from PSD 15601, \$29,494.00 from PSD 15620, \$59,724.00 from PSD 15680, and \$34,972.00 from PSD 15711 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
