Said Council hereby finds that that certain map surveyed by THOMAS H. SHUTTLEWORTH, a Licensed Land Surveyor, entitled "5672 RILEY STREET VILLAS Being a subdivision of Lot 10 and a portion of Lot 9 in Block 1 of Silver Terrace Addition in the City of San Diego, County of San Diego, State of California, according to Amended Map No. 695 filed in the office of the Recorder of said San Diego County on December 12, 1891, including a portion of Riley Street as dedicated to public use.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; and said map and the subdivision of land shown thereon is hereby approved and accepted.
