APPROVING MAP OF SUNGLOW SUBDIVISION AND
ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S
ASSURANCE OF COMPLIANCE WITH THE AFFIRMATIVE
MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San
Diego, as follows:

Said Council hereby finds that that certain map surveyed
by GLENN R. FERGUSON, a Licensed Land Surveyor, entitled
"SUNGLOW SUBDIVISION Being a subdivision of a portion of
Pueblo Lots 1244 and 1245 of the Pueblo Lands of San Diego,
in the City of San Diego, County of San Diego, State of
California, according to Map thereof made by James Pascoe
in 1870, a copy of which said map being filed in the office
of County Recorder of San Diego County, and is known as
Miscellaneous Map No. 36.," is made in the manner and form
prescribed by law and conforms to the surrounding surveys'
that said map and the subdivision of land shown thereon
is hereby approved and accepted; and said Council hereby
accepts on behalf of the public Sunglow Court for public
purposes, and said street is hereby declared to be a
public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby
accepts on behalf of The City of San Diego, a municipal
corporation, the easements for the construction and
maintenance of sewer and drainage facilities, as granted
and shown on said map and subject to the conditions set
forth thereon.



BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, CAMEO DEVELOPMENT COMPANY, a California corporation, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of SUNGLOW SUBDIVISION.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
