BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of FORREST W. BREHM, an unmarried man, executed in favor of The City of San Diego, bearing date of September 20, 1979, granting to said City a street right of way including any or all appurtenances thereto, together with the right of ingress and egress, over, under, along and across that portion of Lot 8, Tract 875 of ZSCHOCKELT'S SUBDIVISION, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named CAMINO DEL RIO SOUTH.
