

RESOLUTION NO. R-252870

WHEREAS, the Council authorized a contract with Proprietary Computer Systems, Inc. (PCS) in 1974 for text-editing capability through the time-shared use of a computer for recording, editing and composing camera ready copy for printing of the budget document; and

WHEREAS, the Council subsequently renewed the agreement with PCS for Fiscal Year 1975, 1976, 1977, 1978, 1979, 1980 and 1981; and

WHEREAS, other City departments have project uses which require PCS's services; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Park and Recreation and General Services Departments are hereby authorized and empowered to purchase computer services from Proprietary Computer Systems, Inc. (PCS) by way of purchase order.

2. That the purposes and amounts which are hereby authorized are as follows:

<u>Amount</u>	<u>Division</u>	<u>Purpose</u>
\$5,000	Communications and Electrical, General Services Dept.	Billing calculations for maintenance of State traffic signals and street lights will reduce clerical processing time.
\$20,000	Buildings Division, General Services Dept.	Service requests are computerized providing for more efficient scheduling and control.

\$5,000	Streets Division, General Services Dept.	Same as Buildings Division.
\$15,000	Equipment Division, General Services Dept.	Computer services are used for control of the preventative maintenance program for the City's motive equipment.
\$10,000	Solid Waste Division, General Services Dept.	Computerized personnel data provides greater management control over industrial leave, light duty hours and other leaves. Also, computerization will facilitate billing and revenue processing while greatly reducing clerical time.
\$15,000	Park & Recreation Dept.	Computerized fixed assets inventory, outside contracts, and computerized personnel data provide for more responsiveness, more administrative control, and save research and typing time.

3. That the terms and conditions of these purchases shall be pursuant to the terms and conditions set forth in the PCS/APLSV and PCS/Text Time-sharing Contract on file in the office of the City Clerk as Document No. RR-252870.
