BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, entitled "BAY CREST CONDOMINIUMS Being a subdivision of Lots 1 through 43 inclusive of Bay Crest, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 5334, filed in the office of the County Recorder of San Diego County, January 24, 1964, together with Groton Street, Groton Way, Basilone Street and the alley adjoining Lots 29 through 43 of said Bay Crest Tract, all as dedicated to public use.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.
